### Terms

- Rates are subjected to change without prior notice. Customer is advisable to check rate by calling 1300366 832.
- Applicant must inform 1World if there is requirement to discontinue provided by written notice to 1World through email or fax. Applicants must ensure that information provided to 1WORLD is updated. Applicant must inform 1WORLD of any changes in the information provided via Fax or Email instruction. Please note that by pre-selecting the home phone number to 1World, Applicant has selected 1WORLD as the primary international, national and mobile provider for office or landline. To use other provider national long distance service/international long distance, customer must dial an override number.
- By pre-selecting with 1World, all national, mobile and international long distance will be via 1World system once the application has been approved.
- Customer that selected the number to 1World must still dial 1World local access number to use the account. Please refer to method of usage for detailed information.
- For mobile phone selection to 1WORLD, applicant must always dial in to 1WORLD access number as provided to access the international and national long distance. For more information, please contact customer service.
